Subject: - Extension of timeline and provision of Edit Functionality on the Sports Infrastructure Portal.

Kindly refer to this office letter issued vide Memo No. 12/60-2025 CCA (2) dated 24.06.2026 and dated 08.07.2026 and dated 09.07.2026 on the subject cited above.

The progress of data submission on the Sports Infrastructure Portal has been reviewed, and it has been observed that, **as on closing date i.e. 13.07.2026, 88.49% of the Government High and Senior Secondary Schools have submitted their information on the portal.**

After reviewing the progress of data submission, the Department has decided to extend the closing date of the Sports Infrastructure Portal up to 20.07.2026 (midnight).

All District Education Officers are, therefore, directed to ensure that all Government High and Senior Secondary Schools under their respective jurisdiction complete the submission of requisite information on the portal positively by 20.07.2026. Schools that have already submitted their information may also be advised to review the data submitted by them and make necessary corrections, if required, within the extended timeline.

For any technical assistance, the In-charge of the concerned school may contact the Helpdesk at 0172-5049801 on all working days from 09:00 A.M. to 05:00 P.M. The concerned School Code may kindly be kept ready while contacting the Helpdesk.

Note: It has been observed that some schools have not selected the Civil Structure items during final submission. All schools are directed to verify the uploaded report. If the Civil Structure items are not displayed, the data may be edited/updated and the revised report uploaded within the extended timeline.

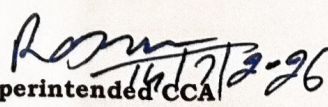
